**ELL Enrollment**

**Grade Span**

The grade span used for AMAO targets is grades K-6 and grades 7-12.

**Language Proficiency Category**

- A = Non-English proficient in speaking, reading and writing
- B = Limited English proficient (student is non-English proficient in at least one of the language modalities of speaking, reading, and writing or at least limited in two of the language modalities of speaking, reading, and writing)
- C = Fluent in two of the language modalities and limited in one
- D = Monitored student for minimum of two years for English proficiency (student is fluent in all three language modalities)
- E = Exited, Former ELL student who is fully proficient in English speaking, reading and writing and has been exited from an alternative language services program and fully assimilated into the mainstream.
- O = Identified as ELL but opted out of services by parent

**2005 ELL Enrollment**

The grade span used for AMAO targets is grades K-6 and grades 7-12.
