The Board discussed the Board Meeting Agenda and Review of Consent Agenda

Full Day Kindergarten

- Dave Rowe presented on Full Day Kindergarten. Requests are being accommodated for both Full Day and Half Day based on staffing. Nebo currently has 76 sessions of Full Day Kindergarten throughout the district.
- 🖌 School Counselors
 - RaShel Shepherd shared the efforts of counselors with students over the last school year. Counselors worked with students who were credit deficient, struggling emotionally, or applying for scholarships, college, and trade schools.

The Board reviewed the following policies with recommended updates:

- Policy IIA- Instructional Materials Policy
 Changes to the policy include updates consistent
 - with SB 55 (2023), including
 - clarifying terms and process for board approval of materials
 - updating waiver of participation provisions per HB 348 (2023)
 - adding requirement that materials be consistent with individual freedoms per HB 427 (2023).
- Policy INDA- Patriotic, Civic & Character Education
 Changes to the policy include
 - a review and technical updates consistent with updated legislative numbering
 - removing reporting requirement per HB 387 (2023).

 - Updated School Resource Officer (SRO) provisions per HB 61
 - Updated law enforcement provisions and added reintegration plan requirement per HB 304
- Safe School Environment Policy
 - The board approved the Safe School Environment Policy with the following change:
 - Added requirement for employee and principal notification of dangerous weapons per HB 60
- Home School and Other Compulsory Education Exemptions
 Policy
 - The board approved Home School and Other Compulsory Education Exemptions Policy with the following change:
 - Added requirement to affidavit that parent not be convicted of child abuse per HB 30
 - Bond Sale
 - The board approved the sale of voter-approved bonds to continue construction on the High School Projects.
