    - Added requirement to affidavit that parent not be convicted of child abuse per HB 305



#### ✓ ITEMS FOR BOARD ACTION

- The Board approved and authorized the issuance and sale of not more than \$76,000,000 aggregate principal amount of general obligation bonds and related matters
  - The \$76,000,000 will be used toward the construction of Springville High School and is part of the \$298,000,000 bond that was approved by voters In 2018
- The Board approved the Property Tax Rate
  - State law requires each taxing entity to take official action to set tax rates for the coming year
  - This is an annual process
  - The tax rate Is 0.007425 for this year which is a decrease from last year's rate of 0.007583
- The Board approved the K-3 Early Learning Plan Goals
- After two months of review, the Board approved the following policies:
  - Policy GCPD Employee Discipline, Admin Leave and Orderly Termination
  - Policy IKFA Graduation Ceremonies
  - Policy BD- Board of Education Meetings
    - Made public comment period mandatory per HB 21
    - Updated public notice requirements per SB43
